Financial Obligation Agreement

This Financial Obligation Agreement is between Team Pittsburgh Aquatics (Pittsburgh Aquatic Program) and

In order to maintain the high level of programming and operation for TEAM PITTSBURGH, providing for both the membership and the coaches, an environment which promotes professionalism in coaching and success in swimming, we the undersigned FAMILY member, acting on behalf of the FAMILY, and HEAD COACH of TEAM PITTSBURGH find it necessary to enter into this AGREEMENT OF FINANCIAL OBLIGATION.

Payments are divided into trimesters (three seasons) in each Team Pittsburgh year (September-August). They are Fall (September-December), Winter (January-April), and Summer (May-August). The charges for the family are per season. The family will be obligated for payment of the full season charge upon signing of this agreement for each season that the swimmer(s) remain(s) active. No discounts can be given for practices that are missed due to sickness or ability to attend practices, involvement in other activities, or any other reason, except when an exception is granted by the Board of Directors of Team Pittsburgh.

This agreement binds said family to, upon entry and acceptance to the team after a Membership Application has been filed, payment of 1/2 of the stated season fees figured below, plus full payment of any applicable USA Swimming Fees and Registration (transfer) costs, and a payment of \$50 per family to be held in an Escrow account used for the purpose of paying meet entries and special purchases by family members.

In addition, the Family agrees that the remaining 1/2 of the season fees must be paid by the end of the first week of third month of the season in which the swimmer(s) is swimming. Additionally, the Family agrees that any purchases made as sales items on credit from Team Pittsburgh must be paid within 15 days of billing.

In addition, each family will be charged a fund-raising fee of \$200 per season (three seasons per year, for a total of \$600 per year). This charge is initiated to encourage parents to work at swimming meets that Team Pittsburgh is the host. Families, by working meets, may eliminate all or part of their family fund-raising obligation. However, no more than \$600 may be earned in any one year (three trimesters beginning with the fall tri-mester) without the PRIOR agreement of the board of directors of Team Pittsburgh. We will make it possible for you to substantially reduce, if not totally erase, your fund-raising obligations, IF YOU VOLUNTEER TO DO SUBSTANTIAL WORK at meets. If you choose NOT to volunteer to work, you will owe the entirety of your fund-raising obligation with PAYMENT IN FULL before your child will be able to continue to swim with Team Pittsburgh.

Other programs or projects initiated for the purpose of raising money for this obligation must be approved and coordinated by the Board of Directors of Team Pittsburgh. Other projects (advertising, t-shirts, etc) may be provided to the families to help defray the cost of season fees and/or the fund raising obligation. However, such projects must first be approved by the Board of Directors of Team Pittsburgh prior to the initiation of the project.

If this agreement is broken by the Family, it is understood that all Family members will be excluded from any future activity with Team Pittsburgh including, but not limited to swim practice opportunities, swim meets, meetings and other team functions, but does not release the family from financial obligations accrued for the season of the agreement.
